Did You Know?

Metformin was derived from the French Lilac plant. Here is the quote from Wikipedia: "The biguanide class of antidiabetic medications, which also includes the withdrawn agents phenformin and buformin, originates from the French lilac or goat's rue (*Galega officinalis*), a plant used in folk medicine for several centuries. [108] *Galega officinalis* itself does not contain any of these medications, but isoamylene guanidine; phenformin, buformin, and metformin are chemically synthesized compounds composed of two guanidine molecules, and are more lipophilic than the plant-derived parent compound.
